5. To conduct an on-the-spot enquiry into any incident of ragging referred to it by the faculty or student or parent or guardian, as the case may be: and the enquiry report along with recommendations shall be submitted to the Head of the Institution for action.
6. To ensure the display of posters on Institution and Department Notice Boards and other prominent designated places.
7. To offer services of counseling and create awareness to the students.

Further it is requested to all the committee members to maintain all the required records related to the complaints received, meetings conducted and actions taken against the complaints to the Principal and submit the report monthly.
